3.1. Senate Executive Committee

3.1.1. Membership (22): The Senate Executive Committee shall consist of 19 ex officio members and three elected members.

3.1.1.1. Ex officio (voting): Chair of the Senate (who shall be the Chair of the Executive Committee); Senate Vice Chair; Secretary of the Senate (who shall be the Secretary of the Executive Committee); Treasurer of the Senate; the Chairs of the Committees on (a) Academic Policy and Planning, (b) University Resources and Planning, (c) Faculty Affairs, (d) Committees and Elections, (e) Constitution and Bylaws, (f) Undergraduate Curriculum, and (g) Diversity, Equity, and Inclusion; an ASCSU Senator chosen from and by the CSU Academic Senators; Provost and Senior Vice President; Chair of Undergraduate Council; Chair of Graduate Council; President of the Associated Students or designee and; a staff senator chosen from and by the staff senators.

3.1.1.2. Ex officio (non-voting): President of the university's chapter of the faculty unit's collective bargaining agreement; the Immediate Past Chair of the Senate.

3.1.1.3. Elected (voting): Three faculty senators elected from and by the elected members of the Senate, with no more than one from a college or equivalent academic unit.

3.1.1.4. The Senate Parliamentarian, Senate Analyst and **Instructional Technology Services staff support** the function of the committee, and as such may attend regular and confidential meetings; however they are not active members of the committee. They may not vote or make motions, and may only address the body by invitation of the Senate Chair.

RATIONALE: ITS Staff need to be acknowledged in the membership clause to ensure they can remain in the room when SEC meetings go into Executive Session. Otherwise, we need to ask them to leave, and we need them to continue to support the IT elements of the meeting.

The Academic Policy and Planning Committee (AP&P) moves that the Senate adopt the following changes to UNIVERSITY POLICIES: Academics, Curriculum Changes, Undergraduate and Graduate.

5.4. New Graduate Courses and Emphases, and Changes in Existing Courses (Major), Emphases, Advanced Certificates, and Requirements¹

- 5.4.1. Curriculum proposals shall be sent to the Graduate Curriculum Subcommittee for approval.
- 5.4.2. Curriculum proposals approved by the Graduate Curriculum Committee shall be reported to the Senate, AA-AVPs, Graduate Council, Associated Students, and Academic Deans Council as information items.
- 5.4.3. New Graduate Courses and Emphases, and Changes in Existing Courses, Emphases, Advanced Certificates, and Requirements Flow Chart:

Proposed language to be included in the Curriculum Guide:

Curriculum Changes, Minor Modifications for Graduate Courses

Generally, the review path for graduate course modifications involving only the initiating college's curriculum will no longer include the Graduate Curriculum Committee or Graduate Council. Proposals approved by the College Dean (or designee) will be sent simultaneously to the Senate Executive Committee, Graduate Curriculum Committee, and Graduate Council. Unless objections arise, curriculum proposals will then be included in the Senate report as an information item.

There will be situations where additional review is needed:

- Graduate Curriculum Committee will review if the course modification is major, for instance if unit changes are required, or the change involves other colleges.
- Student Learning/Community Engagement Committee will review if the change involves adding or modifying a Service Learning or Community Engagement designation.
- International Affairs University Senate Council will review if the change involves adding or modifying Global Learning designation.

¹ See Curriculum Guide for current list of course modifications requiring additional review and approval.

- Changes to the list of situations where additional review is needed can be made by approval of AP&P.

Examples of minor graduate modifications include:

- Updating course title OR course description that does not impact other colleges and that reflects only minor changes in content.
- Updating Instruction Mode(s)
- Updating Course Note(s)
- Updating current and/or deleting enrollment requirements (i.e., prerequisites, corequisites, concurrent); addition of requirements outside of college requires that proof of consultation be attached to the proposal.
- Updating Instructional Methods (CS codes)
- Updating Course/Department/College Specific Requirements
- Program changes that only reflect minor modifications to existing courses

Rationale:

In AY 2022-23, the Senate approved a new process for making changes to current curriculum (see 5.2 in Curriculum Changes, Undergraduate and Graduate). Under this new and abbreviated process, minor modifications to undergraduate courses do not follow the full curriculum approval process. These courses undergo an abbreviated curricular review up through the college before being submitted to the Senate as an information item. The curriculum guide outlines what constitutes major/minor modifications, and AP&P is charged with maintaining those criteria.

Graduate Dean Tracy Love, after consultation with her office, recently approved applying this change to minor modifications of graduate courses. Dean Love reviewed the list of minor modifications proposed above and specifically approved these items to be considered minor modifications for the purposes of curriculum approval. Modifications considered minor will follow the abbreviated process of review up through the college before moving to the Senate through information items.

The Academic Policy and Planning Committee (AP&P) moves that the Senate adopt the following changes to UNIVERSITY POLICIES: Academics, Courses, Experimental and Interdisciplinary Limited-Duration.

Courses, Experimental and Interdisciplinary Limited-Duration

(Numbered 296, 496, 580, and 596, and General Studies 250, 350, 550)

- 1.0 The 496 number shall designate defined, selected topics not specifically treated in regular Catalog courses. It may thus be used either as an experimental precursor to a new course proposal or as a vehicle to explore current interests through a standard course format, including syllabus, texts of bibliography, explicit procedure or methodology, and an appropriate student population. Unlike the 499 Special Studies course, the topics course should be subjected to a reasonable department or school review for need, relevance, and substance ~~in order to pass a series of reviews~~ before being included in the Class Schedule.
- 2.0 **Residence Courses:** Proposals for experimental and interdisciplinary limited-duration courses shall follow **an expediated curriculum review process as follows:** ~~the same procedure as regular undergraduate curricular proposals but with the following exceptions:~~
 - 2.1. **Experimental and interdisciplinary limited duration courses (initiated in the curriculum management system) shall be approved by the proposing department and college curriculum committees using the College's internal curriculum approval process and then sent to the College Dean (or designee) for approval. Proposals approved by the College Dean (or designee) will be sent simultaneously to the Senate Executive Committee, Undergraduate Curriculum Committee, Undergraduate Council, and the Associate Vice President for Enrollment or designee as an information item. Unless objections arise, curriculum proposals will then be included in the Senate report as an information item.**
 - 2.2. Proposals shall not be constrained by General Catalog and committee deadlines for regular course proposals; they shall be dealt with on demand

and shall be completely processed during one semester for implementation the next semester.

~~2.2. Proposals may go concurrently to the college curricular screening body, the dean of the college, and the Associate Vice President for Enrollment or designee. The process shall conclude with the Undergraduate Topics Subcommittee, which shall report to the Undergraduate Curriculum Committee, which in turn shall report to the Senate.~~

3.0 **Extension Courses:** Proposals for experimental and interdisciplinary limited-duration courses offered for academic credit by Global Campus shall **follow the same process described in 2.1.** ~~be reviewed by the Undergraduate Topics Subcommittee, which shall report to the Curriculum Committee, which shall report to the Senate.~~

Rationale:

In AY 2022-23, the Senate approved a new process for making changes to current curriculum (see 5.2 in Curriculum Changes, Undergraduate and Graduate). Under this new and abbreviated process, minor modifications to undergraduate courses do not follow the full curriculum approval process. These courses undergo an abbreviated curricular review up through the college before being submitted to the Senate as an information item. The curriculum guide outlines what constitutes major/minor modifications, and AP&P is charged with maintaining those criteria. Because special topics courses are not permanent additions to the curriculum, and therefore do not go into the catalog, they are not covered by this recent change.

AP&P maintains that experimental and interdisciplinary limited-duration courses need not go through full curriculum review, since these are short-term special topics or experimental classes (courses numbered 296, 496, 580, and 596, and General Studies 250, 350, 550), typically offered one or two times (no more than four times). They are an ideal mechanism for faculty to try out new pedagogical themes and approaches before submitting a formal course proposal. Special topics are likewise ideally suited for new faculty who wish to teach classes not yet included in the curriculum, but who are unable to quickly propose new courses due to the timing of their hire and/or arrival on campus.

This change would allow the same process of expedited review followed for minor modifications to be applied to special topics. An abbreviated review for temporary courses would ensure flexibility and allow departments to be nimble in the shaping of their programs. AP&P maintains that requiring full review of a temporary course is unnecessarily burdensome on faculty and staff.

 - 3.1.1.1. Ex officio: the Provost and Senior Vice President, or designee; the Associate Vice President for Faculty Advancement and Student Success; **Senate Chair, or designee**; and the Dean of Graduate Studies.
 - 3.1.1.2. Appointed: nine faculty members, one from each **academic** college, the Library, and SDSU Imperial Valley, ~~nominated by the Committee on Committees and Elections and appointed by the Senate~~, at least two of whom shall be elected senators; one staff member ~~selected by the Staff Affairs Committee in consultation with the staff senators and confirmed by the Senate~~; **and** two students ~~appointed in accordance with procedures established by the Associated Students~~.

RATIONALE: Senate Officers are members of URP, DEI and other standing committees. This membership enhances the officers' ability to ensure the work of the Senate proceeds in a timely and efficient manner, it increases communication and provides a consistent avenue for communication regarding important business of the Senate. Senate officers accept the additional responsibility and these committee chairs are in support of the expanded membership.

In the APP charter in particular, the section stricken out are redundant as these requirements govern all committee assignments unless otherwise stated.

The CBL moves that the Senate adopt the following changes to Senate policy file (Bylaws) [for a 1st reading](#).

Bylaws 3.1

There shall be eight Standing committees, as defined in Section 2.1 of these Bylaws. ~~These~~ **Their voting membership** shall be composed of a majority of faculty and may include administrators, students, and staff. Other committees deemed essential for university business shall be designated Senate-appointed university committees.

Rationale: During the past 5-10 years the senate started to add non-voting members to its main body and committees. Several Standing committees are currently out of line with 3.1 given that with the growth in administrative positions more were identified as useful sources of information during committee deliberations. E.g., the position of “Dean of Graduate Studies” and “VP of research and Innovation” used to be one and is now two people. Adding them both to URP will increase the number of admins in that committee by one, even so having both around the table might be useful.

CBL suggests updating 3.1: only **voting** members are counted for the rule that the majority should be faculty (TT or contingent). Hence admins can always be added as non-voting members. In the spirit of shared governance CBL judges that faculty should dominate the vote in Senate committees and hence does not advise to get rid of the rule altogether (Which is a suggestion made by the officers).

Note that CBL is updating the committee structure and naming, however this process will likely take all AY. By updating 3.1 now, other committees like URP can move forwards updating their membership.

 - 3.1.1.1. Appointed (12): nine faculty senators, one from each academic college, SDSU Imperial Valley, and the Library; and three additional faculty, one each from the College of Arts and Letters, the College of Professional Studies and Fine Arts, and the College of Sciences.¹ These members shall be selected by their respective college senators and affirmed by vote of the Senate.
 - 3.1.1.2. Ex-officio:(2): **Senate Secretary, or designee**; Chair of the Staff Affairs Committee, or designee; and the President of Associated Students, or designee.
 - 3.1.1.3. The term of office shall be for one year and begins at the last regular spring meeting of the Senate; it may be extended.
 - 3.1.1.4. The first meeting of each term shall occur immediately following the last spring meeting of the Senate and the outgoing chair shall chair it. The business of the first meeting shall be to elect a successor to the outgoing chair.

RATIONALE: Senate Officers are members of URP, DEI and other standing committees. This membership enhances the officers' ability to ensure the work of the Senate proceeds in a timely and efficient manner, it increases communication and provides a consistent avenue for communication regarding important business of the Senate. Senate officers accept the additional responsibility and these committee chairs are in support of the expanded membership.

1.0 Membership (~~13~~14): 9 faculty, one (1) from each college, the Library, and SDSU Imperial Valley; Associate Vice President for Curriculum, Assessment and Accreditation (or designee); Associate Vice President for Student Affairs and Campus Diversity (or designee); Instructional Technology Services representative (ex officio); Center for Teaching and Learning representative (ex officio); the Assessment and Accreditation Analyst; two undergraduate students.

2.0 Functions

2.1. The Committee shall provide oversight for the program assessment of Degree Learning Outcomes, and shall evaluate assessment plans and progress for all degrees and programs, including those programs accredited by external agencies.

2.2. The Committee shall assess reports for each degree on a regular basis and provide feedback to the respective programs.

2.3. The Committee shall provide the Senate, and, when relevant, the Graduate Council, with an annual report on the state of program assessment across the university, including programs accredited by external agencies.

RATIONALE: These changes add the Assessment and Accreditation Analyst, who currently attends SLOPAC meetings and supports the work of SLOPAC, as an official

member of the committee. The changes also allow the AVP for Curriculum, Assessment, and Accreditation to appoint a designee, aligning this with the other AVP member.

ACTION: The Committee on Sustainability moves that the Senate adopt the following changes to the Policy File regarding the Committee on Sustainability's membership (p. 133 item 2.0). The following changes have been approved by unanimous vote by the current voting members of the Committee on Sustainability.

- 2.0 **Membership** ~~(16)~~ **(21)**: ~~five~~ ten faculty, that is: one faculty member from each academic college, one from Imperial Valley, one from Library, and one contingent faculty member, with no more than two from any one college; one staff member; Vice President for Student Affairs and Campus Diversity, or designee; ~~Associate Vice President for Faculty Advancement and Student Success, or designee~~ Associate Vice President for Curriculum, Assessment, and Accreditation, or designee; Director of Energy and Sustainability, or designee; Associate Vice President for Real Estate, Planning and Development, or designee; Associate Vice President for Business Operations, or designee; SDSU Research Foundation Director of Facilities, or designee; KPBS General Manager, or designee; CEO of Aztec Shops, or designee; two students.

Rationale:

The rationale for the overall expansion of the Committee on Sustainability's membership to 10 faculty members (i.e., one from each academic college [7], one from Library [1], one from Imperial Valley Campus [1], and 1 contingent faculty member [1]) is to have a more consistent and wider college-based representation like most other larger senate subcommittees. A faculty member from each college would promote the attention to the University's sustainability objectives in each college. In addition, and especially in light of the University's ongoing and important goal to advance diversity, equity, and inclusion, we are proposing to expand membership in an attempt to insure that the membership more closely represents the growing diverse population of students, staff, and faculty at SDSU.

The rationale for the replacement of the FASS designee by a designee from CAA (Curriculum, Assessment, and Accreditation) is that AASHE requires assessment of how sustainability is integrated into the curriculum across the university. With the goal of identifying sustainability-based courses in the SDSU catalog, we anticipate the need for someone from the SDSU Curriculum, Assessment, and Accreditation group to replace the representative from the FASS group. All undergraduate and graduate curricular changes are administered through Curriculum Services, who edits and maintains the SDSU catalog. Therefore, their ongoing input and assessment will be crucial to achieving this first goal prior to the subsequent goals of advancing and developing sustainability-based curricula. Dr. Joanna Brooks (FASS) was previously contacted regarding this modification and approved the proposed change prior to our request to update the policy file regarding the proposed change to membership.

Zable Foundation President's Suite at the SDSU vs. Boise State football game in Snapdragon Stadium. Guests included high-level donors and prospects, TCF board members and elected officials. A private lunch was held after the lecture. The lecture provided a unique opportunity to learn more about Joe Kiani's entrepreneurial journey. Among many other awards, he is also the recipient of the SDSU Alumni Award of Distinction. Masimo Corp. grew from a "garage start-up" into a successful publicly traded company, employing more than 8,000 people worldwide. President Biden appointed him to the influential President's Council of advisors on Science and Technology. Mr. Kiani has been "solving the unsolvable" for over 30 years as an engineer and entrepreneur and is a beacon for patient safety and innovation in healthcare.

The President's Lecture Series was created to serve as a dynamic forum to enhance the intellectual life of the university and the greater San Diego community. This forum brings together distinguished innovators, entrepreneurs and civic leaders with our students, faculty, staff and the community. Speakers are invited to share their professional insights and life experiences at a public, on-campus lecture in order to bring about a meaningful dialogue that promotes knowledge, social interaction and critical thinking. Following the lecture, a private lunch was held for donors connected to entrepreneurship, health services and engineering.

On Monday, October 16 President de la Torre and Vice President Vargas hosted the 12th annual Evening Celebrating Philanthropy stewardship event. This stewardship event is designed to recognize the critical role of philanthropy and donors to the success of San Diego State and to honor those who have contributed one-million dollars plus to SDSU. 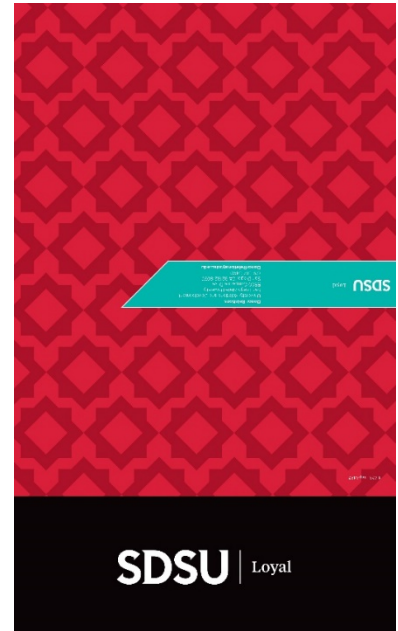

Subject: Information Item Re: Add Dean of Grad Studies to URP (Referral 22/23_17)

Background:

The College of Graduate studies wishes to have representation on URP and has requested that the Senate add the Dean of the College of Graduate Studies (or designee) to URP as an ex-officio member.

Information Item for SEC and Senate:

URP Co-Chairs Hentschel and Jacobs briefly discussed the referral with the Chair of the Constitution & Bylaws Committee, Arlette Baljon, in May 2023. Chair Baljon alerted the URP Co-Chairs to Senate Bylaw 3.1, which mandates that all Standing Committees “shall be composed of a majority of faculty”. The URP charter presently lists 20 total members, of which only 9 are faculty.

The URP Co-Chairs presented this information to the committee during its first meeting of the 2023-24 academic year on 26 September 2023 (the February 2023 referral was not discussed by URP previously). After discussion, the committee concluded the following:

- 1) Because URP is one of the eight Standing Committees of the SDSU Senate and Senate Bylaws dictate that Standing Committees “shall be composed of a majority of faculty” (Bylaw 3.1), URP’s current membership roster (9 faculty seats, one from each college, out of 20 total membership seats) is not in compliance with Bylaw 3.1.
- 2) In the short term, therefore, URP cannot add any additional non-faculty member to the committee without further violating Bylaw 3.1.
- 3) The referral sought representation by the Dean of the College of Graduate Studies (CGS) to URP as an ex-officio member. Because CGS is within Academic Affairs and the VP for Academic Affairs designates a representative to URP (AVP Mary Anne Kremicki), CGS can communicate with their representative on URP to have information brought to URP.
- 4) The committee is willing to invite the Dean of the CGS to participate in URP as a non-voting guest whenever the discussion of agenda items is likely to benefit from the CGS Dean’s knowledge and perspective. Similar invitations can be extended to other key members of the SDSU community when the committee’s agenda warrants.
- 5) In the longer term, URP will consider possible modifications to the roster to bring URP in compliance with Bylaw 3.1, discuss possible remedies developed by the URP Committee with the Constitution & Bylaws Committee, and possibly propose a modification of the URP membership (section 3.4.1 of the Bylaws) to the Senate.
