Principles of Shared Governance: Senate Chair reads principles of shared governance.

Trust is recognized as a fundamental ingredient that is essential for effective shared governance. Without trust, the practices of partnership, inclusion, open communication, ownership, and accountability are likely to break down. SDSU community members have identified three key principles for shared governance at SDSU that all rely on the fundamental ingredient of TRUST: Respect, Communication, Responsibility.

3.2. Senate Town Hall Report (Weston)-.

Chair Weston provided a summary of August 13 Town Hall. He indicated that while successful, future meetings may deal with one or two topics instead of 5. 3.3. Senate Budget Update (Fuller)

Amanda- presented the 2020-21 AY and the 2019-20 AY University Senate budgets. These were both recommended by PBAC and approved by President de la Torre in June 2020. A new request will be submitted for the University Senate budget of 2021-22 AY in October 2020 in cooperation with Provost Ochoa.

Academic Affairs Report

3.4.President's Report (de la Torre)

President de la Torre provided remarks about the upcoming budgeting process. She indicated that her goal this summer was to position the university with the use of one-time funds to have an intentionally broad and long consultation process for base-budget reductions and other budget concerns that will emerge including advancing efforts for new sources of revenue. She indicated support for all senators and the University Senate Committee on University Resources and Planning (CURP) to be involved in this process now that summer break is coming to an end. Senator Wheeler inquired about PBAC and its expanded role in the campus budgeting process including developing new revenue resources. President de la Torre indicated the PBAC would be involved in addressing the structural deficit caused by the State base reduction. In addition, PBAC is going to have a far more complex portfolio of issues that they will consider in meeting their role to advise the president. Secretary Preciado indicated that the Senate could develop Senate principles or values to offer the President de la Torre as part of this year's budgeting process.

President de la Torre invites the use of the new strategic plan to inform deliberations and other forms of advice to her office. Senator Verity commented on the importance to the

University of out-of-state and international student enrollment. He inquired about decline of enrollment as a result of COVID. President de la Torre complemented past leadership in working to develop the 14% enrollment goal for out-of-state and international enrollment. She also complemented the use of the budget revenue from this enrollment; only 70% is treated as base and the 30% is used for one-time expenses. President de la Torre also commended her leadership team (Ochoa, Woods, Vargas) for their efforts to maintain enrollment goals for this coming fall through their coordinated actions. President de la Torre indicated that the SDSUFlex model has served the campus in continuing to meet its mission with a commitment to everyone's well being and the continuity of the academic programs.

3.5. Provost's Report (Ochoa)

As of August 18, enrollment is on target for California resident students (in-State); graduate enrollment also appears to be on track. Campus has used enrollment management structures such as the admissions waitlists to address what could have been dramatic impacts to CAL and PSFA. International enrollment appears to be on track. Out-of-state students freshmen, transfers, and graduate students have deferred enrollment to Spring 2021 or for a year given the COVID 19 challenges. This will have an expected \$ 8 million one-time cut to the operating budget. Tuition resources are healthy thanks to close monitoring and adjustments by the enrollment management group and other leaders in Academic Affairs.

109 tenure-track faculty requested extensions for their RTP reviews. The Provost also indicated that efforts began in March to support faculty research activity that was interrupted by COVID-19. The Provost and VP for Research Welter reviewed over 200 faculty research requests for campus repopulation to continue or renew their research activities. Colleges and departments have initiated requests for repopulation that have been reviewed in collaboration with AVP for Administration Jessica Rento. The Library operation plan is also moving forward thanks to new dean Scott Walter. The governor's and county health orders will guide the library's operation. Individual faculty have requested use of campus classrooms to support their teaching activities.

Academic Affairs will continue planned searches for the Fowler College of Business dean (national search) and the Dean of Graduate Studies. The dean of graduate studies search will be internal. A new internal search is underway for the AVP International Affairs and another internal search for the Vice Provost for Academic Affairs position will begin in Spring 2021. For all the positions, the Provost is committed to working through our shared governance procedures to form search committees for these senior administrative positions. This commitment extends to all three positions that do not have specific guidelines listed in the policy file.

Report from Joanna regarding Academic Operations Guidelines. These guidelines were developed by a broad advisory group that included senate representatives, associate deans and the Academic Deans Council.

Guidelines should address most questions. If they do not, faculty should start inquiries through their department chairs or school directors or deans. This will help Academic Affairs develop new guidelines on issues that emerge through an established consultation procedure.

AVP Brooks also indicated that 50 new tenure track faculty were welcomed by the Provost Ochoa at a program in the morning. This is the most diverse group of faculty with about ½ of them from underrepresented groups.

The President and Provost will visit colleges and departments. Also, an RTP taskforce is going to be established to review several factors impacting the RTP. A group of 15 to 20 will serve on this task force to look at critical issues that have emerged through this recent cycle. The Senate will see these recommendations through AP&P and Faculty Affairs committees and new policy (if needed) following the normal University Senate process.
