### 4.1.5. Search Committees - University Administrators

Motion to approve this policy update as amended passed by unanimous consent.

I would like to sincerely thank the Senate and especially the AP\&P committee for your time and thoughtful work that went into this proposal to standardize several of our search committees. At this time, I receive this action only, as I believe that there is great value in differentiating the composition of search committees based on the unique portfolio and expertise needed to successfully identify the best leaders for the positions identified in this section, and moving "additional elected seats" to an ad hoc process risks denying multiple critical voices which have long been a part of these important searches. As an example, having multiple faculty librarians (in addition to outside faculty) to inform the search process for the unique role of the Dean of the Library is important to me to preserve, and would be impacted by the proposed new language which limits the number of faculty which can be elected from one unit. Similarly, in any future search for a Vice President for University Relations and Development, in addition to the current five faculty voices, it has been critically important to me to have the input of development officers and development staff themselves, alumni voices, foundation voices (as the role serves as the automatic president of the Campanile Foundation, and its board should have a seat on the selection committee), and athletics representatives, in addition to student voices. These categories are all currently defined in Senate policy, but would become subject to individual approval or denial under the proposed replacement standard language, which could negatively impact the comprehensiveness of the process for the campus and its future presidents. I would like my office to engage with the senate officers and the AP\&P committee to identify what components of the current and proposed new/standardized structures might make sense for these committees such that they maximize their chances of a highly successful search, allow for expertise local to a division or college to be uniquely captured, and which achieve a number of the other goals as stated by the AP\&P committee in their current proposal.
